GUIDANCE NOTES**TRANSFERRING SHARES INTO THE LLOYDS BANKING GROUP SHAREHOLDER ACCOUNT**

You can participate in the Shareholder Account **only** if the following conditions are met:

- you are aged 18 or over; **and**
- you are a resident in the UK, European Economic Area (EEA), Isle of Man, Channel Islands, Switzerland or Gibraltar.

You **must** also meet **at least one** of the following conditions:

- you must already hold shares in the Shareholder Account;
- you are transferring your shares from one of the following providers:
 - Halifax Share Dealing
 - Lloyds Private Banking
 - Other parts of Equiniti

POWER OF ATTORNEY

If you intend to act as Power of Attorney on behalf of an owner but you have not registered the POA document with us yet, send us either the original document or a photocopy alongside this form.

If sending a photocopy, please make sure every page is signed with an original signature, either by the person granting the Power or by a solicitor or stockbroker, to confirm that it is a true and complete copy of the original.

Further documents may be required in order to confirm your identity. **There are additional requirements for Power of Attorneys obtained outside of the UK. Please check www.shareview.info/shareview/powerofattorney or contact Equiniti Financial Services Limited for further details.**

CONFIRMING YOUR IDENTITY
